



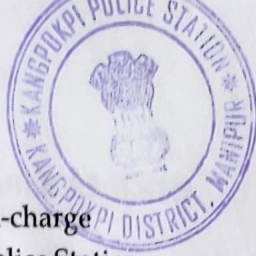

Subject :- An application file for lodging of FIR in Cognizance Order by the Supreme Court 25/09/2023 H.D. Order of the Governor Of Manipur dated 10/10/2023 against the protection of my Homestead plot with Pacca fencing at 91 Meitei Langol-2009, Imphal West District.

Sir,

With due respect, I the undersigned would like to request you for favour of initiation and necessary action on the above cited subject.

That, Sir, on account of the present ethnic communal war that flared up between Kuki and Meitei community from 3rd May, 2023 till date, the condition of staying at the valley became unsafe for life and we fled from Imphal by leaving our rented house on 3rd May, 2023 night. We were shifted to IGAR (S), C/O 99 APO, Mantripukhri at Imphal East. On 9th May, 2023 I along with my family members reached and took shelter as displaced person in one of my relative's house at Kangpokpi ward No. 8, Kangpokpi District.

That, ever since from 4th May, 2023 onwards, I could not learn about my things that were left and I could not made complaint to the police. However, after a lapse of 11 (eleven) months I was informed on 30th April, 2024 by a reliable friend who is very intimated to me that my plot located at 91 Meitei Langol-2009 which was under construction was raided by Meitei/Meetei miscreants robbed all the construction materials etc. and left my plot and pacca fencing which worth is about Rs. 80,30,000/- (Rupees eighty lakhs thirty thousand) only by the Meitei/Meetei miscreants in the last week of April, 2024 however, could not ascertained the exact date and time of occurrence.

As such it is my humble request to your good office to enquire about my things (i.e. properties) through your kind discretion.

I shall be ever grateful to you.
