Subject: Report.

Sir,

I have the honour to report that today i.e. the 8th April, 2024 received a reliable information about the presence of some anti social elements are loitering in and around Mantripukhri Bazar Imphal East District. Based on the said information, teams of CDO Imphal East Unit under the guidance of Shri. K. Meghachandra Singh MPS, SP/IE District, under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE and led by Inspt. Kh. Henery Singh, OC-CDO/IE and assisted by Kulabidhu Soibam, Hav. No.-0T11001, MPTC presently attested at CDO-IE conducted a random frisking and checking to the suspected passersby.

In that, one suspected car, (Maruti Suzuki Alto) silky silver in colour, was detained for verification. On verification, the driver of the car identified himself as one; **Md. Juma Khan (34 years) S/o (Late) Raja Ali of Saiton Awang Leikai, Bishnupur District.** On verification the occupants of the car, they identified themselves as ; (i) **Hareram Parsad (38 years) S/o – Mandan Prasad of Bihiya Thakur Bari Road, PO & PS – Bihiya, District-Ara** and (ii) **Ram Bahadur Khadke (44 years) S/o Krisma Kharke of Paspati Village, PO – Kalapahar, PS – Kangpokpi, Senapati District.** On checking the detainees; one mobile phone, one wrist watch and one wallet were recovered from the possession of the detainee Md. Juma Khan. One mobile phone and one wallet were recovered from the possession of the detainee Ram Bahadur Khadke.

On verification of the detainees, Md. Juma Khan and Ram Bahadur Khadke, they stated that they had kidnapped the detainee (Hareram Prasad) on the advice and command of the said Md. Rahish of Lilong Turel Ahanbi and made a ransom of Rs. 15, 00, 000/- (fifteen lakhs rupees) to safely released from their custody. On verification of the detainee Hareram Prasad, he stated that he was kidnapped by the said Md. Rahish khan and his associates and made a monetary demand of Rs. 15, 00, 000/- (fifteen lakh rupees) to safely released him from their (Md. Rahish and his associates) custody.

So, in the above facts and circumstances bth the detainees **Md. Juma Khan (34 years) S/o (Late) Raja Ali of Saiton Awang Leikai, Bishnupur** and **Ram Bahadur Khadke (44 years) S/o Krisma Kharke of Paspati Village, PO – Kalapahar, PS – Kangpokpi, Senapati District** were arrested from the spot i.e. Mantripukhri Bazar at 6:35 p.m. and seized (i) one car (Maruti Suzuki Alto), Silky Silver in colour b/regd. no. MN – 01K/8293 bearing Engine no. F8DN3319264 & Chassis no. MA3EYD81300763269 along with its registration certificate, (ii) one mobile phone (Redmi 9) bearing IMEI no. 869016054993072 & 869016054993080 along with two SIM cards bearing no. Jio – 89918650400303354452 & Airtel – 8991160990010300371U, (iii) one wrist watch and (iv) one wallet containing a sum of Rs. 18, 500/- (eighteen thousand five hundred rupees), AADHAR Card, Driving License and one PAN card from the possession of the arrestee Md. Juma Khan from the spot i.e. Mantripukhri Bazar at 6: 55 p.m. by observing due formalities. From the possession of the arrestee, Ram Bahadur Khadke, one mobile phone (Redmi A2) bearing IMEI no. 863558064966420 & 863558064966438 along with two nos. of Airtel SIM cards bearing no. 8991000920813693463U & 89915109080072619443H1, one wallet containing a sum of Rs. 1,000/- (one thousand rupees, one AADHAR card and one Voter ID were seized from the spot i.e. Mantripukhri Bazar at 7:10 p.m. by observing due formalities.

Further, the victim (Hareram Prasad) stated that, he was tortured, shifted from place to place and threaten to kill by the said Md. Rahish since he had been kidnapped if his (Hareram Prasad) family fail to fulfil their monetary demand.

Therefore, the above mentioned rescued person namely; **Hareram Parsad (35 years) S/o – Mandan Prasad of Bihiya Thakur Bari Road, PO & PS – Bihiya, District- Ara** was handed over to his family members and the two arrested persons namely; **Md. Juma Khan and Ram Bahadur Khadke** along with the seized items are being handed over to you for taking up further legal procedures against them.
