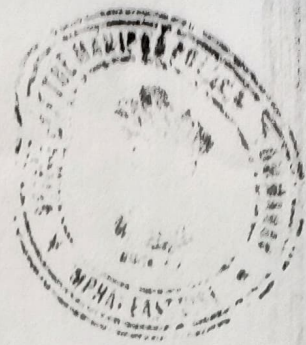

Subject: Report.

I have the honour to report today i.e., 10th May, 2024 at about 1:00 a.m., received a reliable information from 4 AR corroborated with our own intelligence about the presence of some anti-social elements suspected to be active members of the outfit PREPAK at the general area of Naharup, Imphal East District, threatening/disturbing peace and normalcy life of the common people of the area. Based on the said information, teams of Imphal East District police assisted by ASI. S. Suraj Singh of CDO/IE Unit and Havd. OT11001 Kulabidhu Soibam of MPTC now attached with CDO/IE unit Unit led by Inspt. Kh. Henery Singh, OC-CDO/IE Unit under the command of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE and under the overall supervision of Shri. K. Meghachandra Singh, MPS Superintendent of Police Imphal East District conducted a random searched operation. In that, one car (Honda City), white in colour, was detained for checking and spot verification at Naharup Thongkhong near Auto-rickshaw parking, Imphal East District. On checking his body, one 9 mm Pistol loaded with four live rounds in the magazine, one mobile phone and one wallet were found and recovered from his possession. On verification, the man identified himself as one **Huldrom Mishal Singh @ Nongshaba @ Abungo (24 years) S/o (Late) Dayamol Singh of Pishumthong Oinam Leikai, Singjamei PS, Imphal West District** an active member of the outfit PREPAK (Pro). On further verification, the detainee stated that he joined the said outfit, PREPAK (Pro), through one Mr. Loya of PREPAK (Pro) in the month of December, 2023 and presently working under his command. So, the detainee was arrested from the spot i.e. Naharup Thongkhong near Auto-rickshaw Parking, Imphal East District at 1:45 a.m. by observing due formalities.

One 9 mm Pistol marked as 'ELEY MADE IN U.S.A, AUTO-PISTAL 9 MMA, 77711' loaded with four live rounds in the magazine, one car, (Honda City), white in colour, without regd. no. bearing Engine No. L15A74134937 and Chassis no. MAKGM25AEDN404787 and one mobile phone (Redmi 12 5G) bearing IMEI no. 863199064344506 & 863199064344514 along with one Jio SIM card bearing no. +91 70054 85188 and one wallet, black in colour, containing a sum of Rs. 100/- (one hundred rupees only) were seized from the possession of the arrestee (Mishal) at 1:55 a.m. by observing due formalities.

Therefore, the arrested person along with seized items is being handed over to you for taking up further necessary legal action against him.




