With due respect, I would like to state the following for your kind attention necessary action.

That, on the 4th May, 2023 I along with my family members had left our residential house at New Lambulane 3rd Street, Imphal East District under the jurisdiction of Porompat police Station for the safety of our life due to prevailing bloody ethnic clash between Kuki and Meitei. We were shifted to 1st MR on 5th May, 2023 and on 12th May, 2023, I along with my family members reached Kangpokpi and took shelter as displaced person in one rented house at Keithelmanbi. Ever since from 4th May, 2023 onwards, I could not learn about my things that were left and I could not made complaint to the police.

However, on 27th April, 2024 I was informed by reliable source that on 18th April, 2024 some unknown valley-based miscreants had trespassed into my house, damaged and looted/stolen my properties which includes electronic items, furnitures items, traditional ornaments, kitchen utensils, etc which worth is estimated to be about Rs. 13,00,000/- (Eighteen lakhs) only.

It is, therefore, requested you kindly to look into the matter and take up a necessary legal action as per the law of the land.
