




Subject: Request to register FIR against the illegal occupation and
looting/plundering of properties

Dear Sir,

I wish to state the following for your kind attention and necessary
action.

That, I along with my family members had left our residential house New
Lambulane 1st street, Imphal East under the jurisdiction of Porompat Police
Station on 4th May, 2023 for our own safety due to the ongoing ethnic crisis in
Manipur. Since then, we have not been aware of the condition of our house
and properties, whether it remains intact or damaged/looted. As per the
directive of the Hon'ble Supreme Court of India dated 25th September,
2023 the State government is directed to ensure protection of the properties of
displaced persons and prevent encroachments. The Commissioner (home),
Government of Manipur had issued an order No. H-3608/2/2023-HD-HD dated
the 16th October, 2023 in the name of the Hon'ble Governor of Manipur
directing all relevant Deputy Commissioners and Superintendents of Police to
implement the said directions of the Hon'ble Supreme Court of India.

That, inspite of the above stated orders, I came across rampant looting
of properties and illegal occupation of houses in our locality (mentioned
above) which went viral on social media, and on being suspicious, I have
enquired the matter in my best level and ascertained through reliable source
that the properties I left behind were looted and plundered by unknown
miscreants and occupied my house House No. 130, Patta No. 189 (New), Dag
No. 2199, Village No. 26(A)-Nongpok Inkhoh under Porompat Sub-Division at
New Lambulane 1st Street, Imphal East District, Manipur in between
21/04/2024 to 30/4/2024.

I request you to kindly look into the matter and take up a necessary legal
action as per the law of the land.
