




Sir,

I have the honour to report that today i.e. the 10<sup>th</sup> May, 2024 at about 8: 00 p.m. received a reliable information from 4 AR corroborated with our own intelligence about the presence of some anti social elements are loitering in and around Kshetrigao-Keikhu area of Imphal East District. Based on the said information, teams of CDO Imphal East Unit led by myself assisted by SI. Uttam Singh of CDO/IE Unit, Jem. S. Bhopen Singh of 4<sup>th</sup> IRB/CDO/IE, ASI. Kh. Victor Singh of CDO/IE Unit and ASI. N. Ibotombi Singh of CDO/IE Unit under command of Inspt. Kh. Henery Singh of CDO/IE Unit under the supervision of Shri. Kh. Herojit Singh, MPS Addl. SP(Ops)IE and under the overall guidance of Shri. K. Meghachandra Singh MPS, SP/IE District conducted a random frisking and checking to the suspected passersby at Kshetrigao Yumkhaibam Leriak and its surrounding areas.

In that, two nos. of suspected vehicle (one Maruti Suzuki Van and one scooter Hero Maestro) coming/riding simultaneously to each other, were detained for verification at Kshetrigao Yumkhaibam Leirak, Imphal East at about 9:00 p.m. On verification, the driver and the pillion rider of the scooter (Hero Maestro), they identified themselves as; **Chingakham Sanajaoba Singh @ Sana @ Dojo (23 years) S/o (Late) Ch. Ojit Singh of Mayang Langjing Tamang, Imphal West and Soibam Sital Singh (24 years) S/o S. Subash Singh of Lamlai Mayai Leikai, Imphal East District respectively**, both the active member of the outfit KCP (PWG). On checking, one mobile phone was found and recovered from the possession of the detainee Chingakham Sanajaoba Singh.

On verification the driver of the Van (Maruti Suzuki), he identified himself as one **Maibam Naresh Singh (24 years) S/o M. Heramani Singh of Senjam Khunou, Sekmai-PS, Imphal-West**. On verification the occupants of the vehicle (Maruti Suzuki Van), they identified themselves as ; (i) **Ningthoujam Ajit Singh (26 years) S/o N. Jiten Singh of Yaingangpokpi Awang Leikai, Imphal East** and (ii) **Chingsubam Thounagamba Meitei @ Amujao (30 years) S/o Ch. Bobo Meitei of Pukhao Santipur, Imphal East, (iii) Wahengbam Premjit Singh @ Abung (40 years) S/o (Late) W. Tomcha Singh of Kanglatombi Bazar Board, Sekmai PS, Imphal West A/p - Yurembam, Patsoi PS, Imphal West, (iv) Irom Anand Singh (24 years) S/o I. Kujakishore Singh of Kongpal Khaidem Leikai, Porompat PS, Imphal East District and (v) Ngangom Rohit Singh (24 years) S/o Ng. Ibomcha Singh of Kongpal Khongkham Leikai, Porompat PS, Imphal East District.**

On verification of all the detainees, it came to learnt that two of the above detainees namely; Irom Anand Singh and Ngangom Rohit Singh were kidnapped today from Thambalkhong Sabal Leikai, Imphal East by the other six detainees namely; **Chingakham Sanajaoba Singh, Soibam Sital Singh, Maibam Naresh Singh, Ningthoujam Ajit Singh, Chingsubam Thounagamba Meitei and Wahengbam Premjit Singh**. On further verification of the above mentioned six detainees, they stated that they were active members of the outfit KCP (PWG) and presently working under the command of one Mr. Ibomcha Singh @ SK of KCP (PWG) and today they came to Kshetrigao, Imphal East to kidnap the above two detainees, Irom Anand Singh and Ngangom Rohit Singh.

On cross verification of the two detainees namely; Irom Anand Singh and Ngangom Rohit Singh, they stated that they were being kidnapped today by the above mentioned six detainees from: Thambalkhong Sabal Leikai at about 4:50 p.m.



On checking the bodies and belongings of the detainees; one mobile phone each was found and recovered from the possession of the detainees Maibam Naresh Singh, Ningthoujam Ajit Singh, Chingsubam Thoungamba Meitel and Wahengbam Premjit Singh. So, in the above facts and circumstances the six detainees namely; (i) Chingakham Sanajaoba Singh @ Sana @ Dojo (23 years) S/o (Late) Ch. Ojit Singh of Mayang Langjing Tamang, Imphal West, (ii) Soibam Sital Singh (24 years) S/o S. Subash Singh of Lamalai Mayal Leikai, Imphal East District, (iii) Maibam Naresh Singh (24 years) S/o M. Heramani Singh of Senjam Khunou, Sekmai-PS, Imphal-West, (iv) Ningthoujam Ajit Singh (26 years) S/o N. Jiten Singh of Yaingangpokpi, Imphal East, (v) Chingsubam Thounagamba Meitel @ Amujao (30 years) S/o Ch. Bobo Meitel of Pukhao Santipur, Imphal East and (vi) Wahengbam Premjit Singh @ Abung (40 years) S/o (Late) W. Tomcha Singh of Knglatombi Bazar Board, Sekmai PS, Imphal West A/p - Yurembam, Patsoi PS, Imphal West were arrested from the spot i.e. Kshetrigao Yumkhaibam Leirak at 9:25 p.m. by observing due formalities.

One van (Maruti Suzuki), Silky Silver in colour b/regd. no. MN - 04A/7332 and one mobile phone (Redmi 10 Prime) bearing IMEI no. 869598051390915/01 & 869598051390923/01 along with two SIM cards bearing no. Jio - 89918650400081540868 & Airtel - 8991160990023896962U were seized from the possession of the arrestee Maibam Naresh Singh at 9:45 p.m. by observing due formalities from the spot i.e. Kshetrigao Yumkhaibam Leirak, Imphal East.

One scooter (Hero Maestro), blue in colour, bearing regd. no. MN-06SE/2389 and one mobile phone (Realme Narzo 50 A) bearing IMEI no. 867095053004653/21 & 867095053004646/21 along with one Airtel SIM card having no. 89911603000062547347 were seized from the possession of the arrestee Chingakham Sanajaoba Singh @ Sana @ Dojo at 9:55 p.m. by observing due formalities from the spot i.e. Kshetrigao Yumkhaibam Leirak, Imphal East.


One mobile phone (Infinix X6525) bearing IMEI no. 356848803151960 & 356848803151978 along with one Jio SIM card having no. 89918650400133034092, one mobile phone (Realmi 13 Pro) bearing IMEI no. 866083067085141 & 866083067085158 along with one Jio SIM card having no. 89918650400115529333, one mobile phone (Realmi Note 7) bearing IMEI no. 863052047079055 & 863052047079063 along with one Jio SIM card having no. 89918650400116139512 were seized from the possession of the arrestees Wahengbam Premjit, Chingsubam Thoungamba and Ningthoujam Ajit respectively from the spot i.e. Kshetrigao Yumkhaibam Leirak at 10:10 p.m., 10:20 p.m. and 10:30 p.m. by observing due formalities.

Thereafter, the above mentioned two rescued persons namely, Irom Anand Singh (24 years) S/o I. Kujakishore Singh of Kongpal Khaidem Leikai, Porompat PS, Imphal East District and Ngangom Rohit Singh (24 years) S/o Ng. Ibomcha Singh of Kongpal Khongkham Leikai, Porompat PS, Imphal East District and the six arrested persons namely; Chingakham Sanajaoba Singh, Soibam Sital Singh, Maibam Naresh Singh, Ningthoujam Ajit Singh, Chingsubam Thoungamba Meitel and Wahengbam Premjit Singh along with the seized items are being handed over to you for taking up further legal procedures against them.


