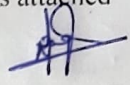

Subject: FIR against looting of my household properties and illegal occupants at my residential home at New-Lambulane 2nd Street, Porompat, Imphal East.

Sir,

With due respect, I would like to state the following lines before you for your kind necessary action.

That, I am a resident of New-Lambulane 2nd Street, Porompat Sub-Division, Imphal East under old Patta number 855 and new Patta number 286/877, Dag No. 2332/2547.

That, on dated 03/05/2023, I along with my whole family members had left our residential house after proper lock & key to saves our life due to the ongoing ethnic violence in the state. Unfortunately, it is learnt from reliable source that all my household properties including furniture, electronic items, essential commodities, clothing items, kitchen & utensil items and A-star VXi Car bearing Regd. No. MN02B-9620, chassis no. MA3EPDE1S00175895, Engine no. K10BN1075905 in the name of my husband Asat Chongloi were ransacked and looted/stolen by unknown miscreants believed to be members of Arambai Tenggol and other radical groups. However, the exact date and time could not be ascertained but suspected to be the 2nd week of Febuary 2024 at around 1:00 pm. Beside, looting of my household properties, my house has also been illegally occupied without my consent after writing Mee Leire on my gate wall.

The estimated value of properties lost, damaged or looted is estimated to be about Rs. 15,40,000/- (Rupees Fifteen lakh and forty thousand only).

The incident could not be reported to my concern PS due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly take up necessary action in this regard.
