



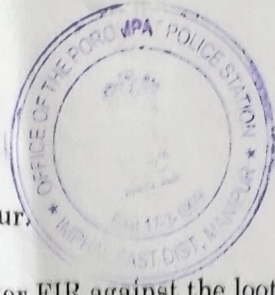

Subject : Request to register FIR against the looting and plundering of properties.

Sir,

With due respect, I would like to state the following for your kind attention and necessary action.

That, I along with my family members had left our residential house at New Lambulane 2nd street, Imphal East under the jurisdiction of Porompat Police Station on the 4th May, 2023 for the safety of our life due to the ongoing ethnic crisis in Manipur.

That, on 4th May, 2024 received an information from a reliable source that the properties I have left behind (enclosed) were all looted and plundered by unknown miscreants in my house having Patta No. 1341 (New), Plot No. 5493/5910, Village No. 26(A)-Nongpok Inkhol under Porompat Sub-Division at New Lambulane 2nd Street, Imphal East District, Manipur. However, the exact date and time of the incident could not be ascertained. The approximate worth of the looted/plundered/damaged is estimated at Rs. 22,41,000/-.

It is therefore, requested you kindly to look into the matter and take up a necessary legal action as per the law of the land.
