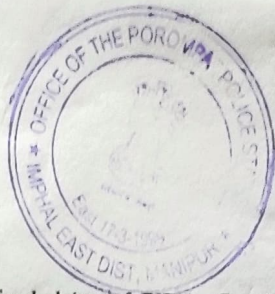

Subject: An application filed for lodging of FIR in Cognizance Order by the Hon'ble Supreme Court dated 25-09-2023 in the Special Leave Petition (Civil) Diary No. 19206/2023 [Dinganglung Gangmei versus Mutum Churamani Meitei & Ors] and passed in the Order by the Governor of Manipur vide Order No. H-3608/2/2023-HD-HD dated 10-10-2023 (copy enclosed) for protection of my house at 2<sup>nd</sup> Street, New Lambulane, Imphal East District.

Sir,

I have the honour to state that on 3<sup>rd</sup> May 2023, when the communal violence started in Manipur, my house was attacked on that night itself. Groups of Meitei miscreants said to be members of Arambai Tenggol broke open my gate and burnt down two cars, one belonging to myself (Breeza car 2023 model/white) (picture enclosed) and the other belonging to my colleague. My house was partially burnt (picture enclosed) by the impact of the burning of two cars. Accordingly, I lodged a complaint at Senapati PS on 17/05/2023 and Zero FIR No. 0(5)2023 SPT PS u/s 436/441/446/427/34 IPC was registered and later transferred to Porompat PS.

Recently, I have seen in many WhatsApp groups that Meitei miscreants entered inside New Lambulane and looted all the houses and stolen the properties in broad daylight of 26<sup>th</sup> February 2024 (picture enclosed). I don't know if my house was also looted or not because I can't go there or send anyone but I highly suspect that my house was also looted because I got a picture of my gate where "U 7" is written in red colour which is said to be a sign of being occupied by Meitei militants (picture enclosed). If it is looted, my properties estimated to be worth Rs. 2,16,98,000/- (Two crores sixteen lakhs and ninety-eight thousand only) (details enclosed) would have been lost. If it is not stolen, I request you to please protect and secure my house as well as my properties inside my house, as ordered by the Home Department, Govt. of Manipur.

Moreover, the whereabouts of my two-wheeler vehicle *Pleasure* bearing Regn. No. MN-06-SA-0176 which I kept at my neighbour's house when I fled with my family on 3<sup>rd</sup> May 2023 night is also not known. I request you to please locate it and keep in your safe custody.

My humble request is to please take necessary action in all the above-mentioned matters for the ends of justice.




