Sir,

With respect, I have to report that on 26/04/2024 at about 9.30 am my younger sister namely Mrs. Sureiya aged about 26 years wife of Md. Umar Khan aged about 32 years of Kiyamgei Takhok Makha serving as a Rifleman of 7<sup>th</sup> IRB was seriously beaten up by her brother-in-law namely (i) Md. Tamijur Rahaman @ Ibothem aged 45 years s/o Md. Azuzur Rahaman and her mother-in-law namely (2) Mrs. Kheirun Bibi aged about 55 years w/o Md. Azizur Rahaman and her husband (3) Md. Umar Khan aged about 32 yrs. s/o Md. Azizur Rahaman all of Kiyamgei Takhok Makha Leikai beaten up by at her husband house. As a result of which my said younger sister has got serious injury on her legs, waist, hand, head and chest etc. and she has been undergoing medical treatment at District Hospital, Thoubal under MLC No. 284/24 dated 26/04/2024. Relevant medical documents are enclosed herewith. The said accused persons has been committing various inhuman cruelty acts to my said younger sister on many different date and time. It is therefore report you to kindly take up a suitable case and punish them as per law. I could not report in time due to lack of legal knowledge and firstly rush for the treatment of younger sister.
