



Subject: Lodging of FIR.

Sir,

With due respect I would like to state that the following for your kind attention and necessary action.

That, on 4th May, 2023 I along with my family members had left our residential house which is located at New Lambulane 2nd Street, Imphal East District, Manipur under the jurisdiction of Porompat Police Station and shifted to 2nd MR for the safety of our life due to prevailing bloody ethnic clash between Kuki and Meitei. Again on 8th May, 2023, I along with my family members reached Kangpokpi Ward No. 15. Ever since from 4th May, 2023, I could not learn about my things that were left and I could not made complaint to Police.

However, on 28th April, 2024 I was informed through reliable source that on 18th April, 2024 some unknown valley based suspected to be Arambai Tenggol trespassed into my residential house, damaged and looted/stolen my properties which includes etectronic items, furniture items, traditional ornaments, kitchen utensils etc. which worth is estimated to be about Rs. 70,00,000/- (Seventy Lakhs) only. The exact date and time of occurance could not be ascertained.

It is therefore, requested you to kindly look into the matter and take up a necessary legal action as per the law of the land.
