Subject: Complaint report of looting of properties and illegal occupation of my residential home at New-Lambulane 1st Street, Porompat, Imphal East.

Sir,

With due respect, I would like to state the following lines before you for your kind information and necessary action.

That, I am a resident of New-Lambulane 1st Street, Porompat Sub-Division, Imphal East.

That, on dated 05/05/2023, I along with my whole family members had left our residential house after proper lock & key to save our life due to the ongoing ethnic violence in the state.

Unfortunately, it has come to our knowledge through a reliable source that all my household properties including furniture, electronic items, essential commodities, clothing items, gold & ornaments, traditional gongs & equipment, kitchen & utensil items, Paddy rice 60 bags and others were ransacked and looted/stolen by unknown miscreants although the exact date and time of the unfortunate incident could not be ascertained but suspected to be around 15th February 2024 at around 1:00 pm. Moreover, our residential house has also been illegally intruded and occupied without my consent by some unknown miscreants after writing "U" in a red colour on my gate wall.

The approximate estimated value of properties lost, damaged or looted is estimated to be about Rs. 47,00,000/- (Forty Seven Lakhs only).

The incident could not be reported to my concern PS due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly look into the matter and take up necessary action in this regard.
