



Subject: Report

Sir,

With due respect, I have the honour to report that today i.e. 29/04/2024, at about 3:00 p.m. teams of CDO/IE Unit led by Inpst. Kh. Henery Singh OC-CDO/IE under the command of Shri. Kh. Herojit Singh, MPS, Addl. SP(Ops)IE and under the overall supervision of Shri. K. Meghachandra Singh, MPS, SP/IE conducted a cordon and search operation in the general area of Mantripukhri bazar and its surrounding area of Imphal East District.

In that, suspected vehicle and passersby were checked and verified. The CDO teams were divided and conducted simultaneous random multiple searched operations of the said area and its surroundings. During the searched operation, one bag, red and black in colour, was found lying abandoned/concealed inside the bushes of the western side of the Mantripukhri Bazar Community Hall, near Auto-rickshaw parking, Imphal East District. On opening the said bag, the under noted arms and ammunitions were found containing inside the bag.

List of the arms and ammunitions ;

- 1) 1 (one) 9 mm Pistol marked as "**BERETTA U.S.A. CORP. ACKK.,MD.-MADE IN USA, BER430479Z**",
- 2) 1 (one) 9 mm Pistol marked as "**PIETRO BERETTA GARDONE V.T, - MADE IN ITALY, F56569Z**",
- 3) 5 (five) nos. of 9 mm pistol magazines, all marked as '**PB CAL.9 PARA MADE IN ITALY**' loaded with 15 (fifteen) live rounds each i.e. 15 X 5 = 75 (seventy five) rounds.,
- 4) 425 (four hundred twenty five) nos. of 9 mm ammunitions.

Accordingly, the above recovered arms and ammunitions were seized u/s 102 CrPC at 4:40 p.m. from western side of the Mantripukhri Bazar Community Hall, near Auto-rickshaw parking, Imphal East District by observing due formalities.

Therefore, the seized items are being handed over to you for taking up further necessary legal procedures.
