Subject : Report.



Sir,

I am to report that today i.e. 29/04/2024 at around 04:00 p.m, while I was at my office of CDO/IE, one of my source man came and reported to me about harbouring of illegal drugs by one Md. Bakta Khan at his chicken centre located at Khabeisoi, near 7 MR Gate. I recorded the statement of the source in writing and a similar copy of the statement dispatched to Superintendent of Police, Imphal-East through OC-CDO/IE. As there was shortage of time due to great risk of the suspect escaping and concealment of evidence, I along with teams of police personnel led by Inspt. Kh. Henery Singh, OC CDO-IE under the command of Shri Kh. Herojit Singh, MPS, Addl. SP(Ops)IE and under the overall supervision of SP-IE rushed to Chicken Center of Md. Bakta Khan located at Khabeisoi near 7th MR gate.

On reaching in the said location one unknown person who later identified himself as Md. Bakta Khan @ Mayangmayum Bakta Khan (44) Yrs S/o Md. Roma of Khabeisoi Mamang Leikai, HNG-PS/IE was found inside the chicken centre. Accordingly I informed him that we have an information of some illegal drugs are being concealed in his Chicken centre. Consequently I told him that his body and belongings as well as the Chicken centre needs to be searched. Further I asked him whether he would like to be searched in presence of Magistrate, Gazetted Officer or independent/civil witness. In the meantime he stated that, searched can be conducted in presence of any Gazetted officer and civil/independent witness.

Accordingly the search is conducted in presence of Gazetted officer and 2(two) Civil witness. That during the searched, one plastic gunny bag (white) is found concealed inside the said chicken centre. That on opening the said plastic gunny bag, the following illegal drugs i.e. (i) 45 Nos. of filled and sealed small plastic bottles (sunset colours) of 100 ml capacity containing a composition of codeine phosphate of 10mg per 5ml. Out of the 45 nos. of said bottles, 17 Nos. of bottles are of ONEREEX, 21 Nos. of ANNIREX, 4 Nos. of TUSSREX-TR and 3 nos. of CODEC-T and 12 Nos. of SEMPLEX strips (SP capsule) having 24 Nos. of capsules per strips (total Nos. of 288 capsules) containing a composition of 50mg of Tramadol Hydrochloride per capsule, were found concealed inside one small nylon hanging bag which were further packed inside one cartoon box, and 62 nos. of empty plastic bottles of the above mentioned drugs along with some empty cases of SEMPLEX strips were found scattered inside the said plastic gunny bag.

That, on enquiring about the said drugs he disclosed that, he has been indulging in the drugs business since 5/6 months. Accordingly, Md. Bakta Khan @ Mayangmayum Bakta Khan was arrested from the spot at 5:30pm. That, on his body searched found one black wallet containing a sum of Rupees Eleven thousand, six hundred and twenty, only (Rs.11,620/-) and one Aadhar Card and one mobile handset (KECHAODA) with one Airtel SIM Card B/No. 9077688274. Accordingly, seized the above mentioned illegal drugs at the spot from his production along with the above mentioned wallet and its content as well as the mobile phone at 5:40pm by observing necessary legal procedure, in presence of two independent witnesses. That, the said seized illegal drugs were properly packed in presence of the Gazetted Office, two civil witness and the arrestee.

It is therefore, the arrestee along with all the seized articles were handed over to you for further necessary legal action.
