A request was made to Mr. Dinamani Khumanthem(AM) S/O (L) Khunmanthem Kanhai Singh resident of Moirangkhom Bokulmakhong, Imphal West for taking the photograph/video being committed. As a result of the technical inspection it is apparent that Md. Sahid Ahamad was indulged in theft of electricity by reason of Sec 135(a)(e) of the Electricity Act, 2003. The connected load at the time of inspection found was 2500 watts. The accused (named above) was found to be utilizing the stolen electricity for the uses of domestic purposed. At the time of inspection as aforesaid the following person(s) S. Khushbu was found in charge of and responsible at the site in question for the theft of electricity.

It is, therefore, requested that an FIR may kindly be registered against above name accused person who was indulging in the act of theft of electricity and he be arrested and proceeded in accordance with provision of law. The undersigned official is duly authorized by the department to lodge the complaint and this complaint is situated at the instance of Imphal Electrical Division-IV and no separate section or consent of Department is required to lodge this complaint.
