Sir,

I am a law-abiding citizen of India and the present complaint is being filed against the accused persons for taking up necessary legal action and punish them in accordance with law for the unlawful activities committed by them. I am well aware of the situation happening in the state of Manipur as I am presently residing in the State of Manipur.

That I have been continuously associated with Shri N.
