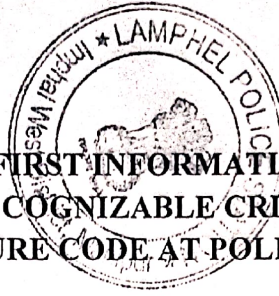



my state government Quarter No.4/Type II-C, Lamphelpat-795004,
Imphal West District, Manipur.

With respect to above subject i am staying in NO.14, 6th cross, Nilgiris road, Kacharkanahalli,
Bengaluru since 01/07/2023. I am working as a Assistant Engineer, Town Planning Department,
Government of Manipur and the government had allotted this quarter to me in 1993.

In connection with the Ethnic Conflict in Manipur, the Meitei refugees are kept in my
government quarter Quarter No.4/Type II-C, Lamphelpat-795004, Lamphel Police Station limits,
Imphal, Manipur State since the evening of 3rd August, 2023 facilitated by a local Meitei club
without my assent. Inside my quarter, all my belongings and properties were there. Since my
properties are now in those refugees' hands, they are using my properties and they may have
steal or sell or damage my properties. I am still paying the house rent every month, which is
debited from my salary.
