D Coy of 37 Bn BSF is deployed in Law & Order duty under PS Lamphel, Distt-Imphal west, Manipur.

- On 17.01.2024 at about 1845 hrs Regimental No. 900064287 ASI/GD Arun Kumar Sharma who was on ADP duty in general area Langol, Phaiphejung informed Coy Commander, Shri Jitendra Singh Bisht, AC that a mob (male and female) is gathering on Langol- games village road at about 150 meters from our Platoon post location, spring villa, housing complex Phaiphejung. Coy Commander immediately informed the matter to SHO Lamphel Inspr Khogendro and simultaneously moved with his QRT towards the Assembly area of the mob. On reaching the Assembly area on Langol- Games Village road the Coy Commander observed an aggressive mob of approx. 300 people (male and female) heading towards the BSF Platoon location. Sensing the intension of the mob to attack the BSF Platoon Post and burn the abundant Kuki houses, Coy Commander and his QRT (Quick Reaction Team) tried their level best to persuade the mob to stop and disperse from the place but the aggressive mob started pelting stones on the BSF QRT team Sensing danger to their lives the Coy Commander in good faith ordered his QRT team member No 214100815 CT/GD Shankar Lal Bhakar and No. 102543588 CT/GD Premesh Kumar to use 01 triple effect grenade (Non Lethal munition) to disperse the mob The mob didn't disperse and continued advancing and pelting stones on the BSF party 01 stone pelted from the mob hit the right arm of No. 102543588 CT/GD Premesh Kumar while he was about to lob the second triple effect grenade. The grenade blasted in his right palm and has caused grievous injuries to the BSF personnel in his right palm. The injured BSF pers is admitted in Shija hospital Langol. Imphal west. To disperse the mob further away two stun grenade were fired by No. 214103274 CT/GD Shri Ram Choudhary. Altogether triple action grenade 03 Nos and stun grenade 02 Nos were used by BSF personnel in good faith to disperse the violent unlawful assembly in Phaiphejung Langol incident. Also, the vehicle No. MN01AW7651 Mahindra Bolero, provided by local administration for use of BSF for Law & Order duty has been partially (front wind screen) damaged by the aggressive mob
 - 3. It is requested to lodge FIR in the aforesaid matter against the persons in the unlawful assembly who obstructed and assaulted the BSF personnel on official duty and damaged the vehicle being used during performance of Govt duty.
