



Sir,

With due regards, I have the honour to make the following report for your kind perusal and necessary legal action.

That on 25<sup>th</sup> April 2023, I take my wife to RIMS Hospital Imphal for delivery. Since her condition was in serious the Doctors operated her (Caesarian Section) on 2<sup>nd</sup> of May 2023 at the said Hospital. Unfortunately on 3<sup>rd</sup> of May 2023 ethnic violence in Imphal broke out. Due to the violence meted out targeting Kuki's even the Hospital was not safe anymore. Thereafter security forces namely, CRPF of Lamphel evacuated us. Since the situation was very severe the security personnels could not take risk of my vehicle, which compelled us to leave the Vehicle in the RIMS campus in a safe place.

That, on 7<sup>th</sup> May 2023 security forces evacuated us again from CRPF Lamphel Imphal and we reach Motbung safely on the same day.

That, the following day, i.e., on 8<sup>th</sup> May 2023, I got a phone number from some acquaintance in Motbung bazaar of one person namely Mr. Lungkingba Haomei @ Thoi Captain from Sekmai, he was known by many people in Motbung village as he was studying in Apex Christian school. They also told me that he was a trustworthy person. So, through that phone number I talk to him and entrusted him to pick up my vehicle from RIMS parking lot, and he was willing to help me. Accordingly the following day he reported to me through phone that he had pickup the vehicle and said that he had reach Sekmai. Thereafter he made no phone call nor pick up my call despite my repeated calls. Till today He did not delivered nor pick up my phone. I could not report the matter in time as I was hoping that he will delivered it someday. But now I have no option but make this report before your good self.
