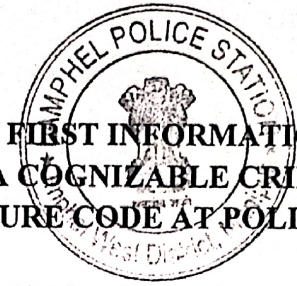





and properties were ^{looted} damaged/burnt, on 9th September,
2023, 10:00 AM by the Meetei communities probably
Akambai Tengpat or Meetei Leepun.
