

Subject: **Request for registration of FIR on looting and destroying of properties occurred at my private residence of Gamngai Veng, Phaipijang, 91- Meitei Langol, Imphal West.**

With reference to the above stated subject, I the undersigned have the honour to state that I came to know in the first week of January 2024 that private properties as details given below have been looted and destroyed by the unknown miscreants.

2. Looted properties includes

1) Electronic items such as 2 nos of Desktop Computers, 2 nos of Canon Printers, 2 nos of Laptop computer, Sony Smart TV (65 inches), 2 nos of Refrigerator of 165 and 200 litres respectively, Kent RO System, 2 nos of Washing Machine, Grinders, Oven, Induction etc. worth Rs **6, 80, 000/- (Six lakhs eighty thousand)**.

2) Furnitures such as 1 no of VIP Sofa set, 2 nos of wooden Sofa set, 6 nos of Godrej Steel Almirah, 4 nos of wooden Almirah, 3 nos of Desktop Computer Table, TV Stands, Dining Table with 6 chairs etc. worth **Rs 5,10,000/- (Five lakhs ten thousand)**

3) Jewellery&Ornament item such as 5 nos of traditional necklace (Khiba), 2 nos of traditional rings, gold chains, necklaceand earring worth **Rs 3,50, 000/- (Three lakhs fifty thousand)**

4) Household items such as 4 nos of King size beds, 4 nos of middle size beds, 15 nos Matress, about 60 woolen blankets, 4 nos of bed box, cushion, utensils, water tank(Syntax), garments belonging to our family, more than 100 nos of traditional shawls etc. worth Rs 7,50, 000/- (Seven lakhs fifty thousand)

5) Traditionnal items: Traditional shawls worth Rs 3 lakhs

5) Traditionnal items: Traditional shawls worth **Rs 3 lakhs**
6) Two wheeler such as 1 no of TVS Jupiter Classic and 1 no of Royal Enfields worth **Rs 2,90,000/-** (Two lakhs ninety thousand) only

7) About 7 Wooden Doors made of Teak worth Rs 1,26,000 (One lakh twenty six thousand) only have also been destroyed and looted.

8) Semi pucca fencing of about 390 feet long worth Rs **700000/- (Seven lakhs)** have also been destroyed.

9) Granary/ Storehouse with about 420 bags of grains worth **4,20,000/- (Four lakhs twenty thousand)** has also been looted

10) Altogether, properties worth Rs 41,26,000/- (Fourty one lakhs twenty six thousand) has been looted and destroyed from my private residence at Hill View Cottage, Gamngai Veng, Phaipijang, Langol, Imphal West. **Date of occurrence is expected to be between August and September 2023.**

3. It is, therefore, requested to register FIR for kind further necessary action.
