Subject : Complaint report

Sir,

I herewith submit this complaint for losses and destruction incurred on my residential building and property located at 91- Meitei Langol Dag No. 632 Patta No. 3177(new) & Dag No. 633, Patta No. 2272 (New) located at Games village zone -III, Opposite to Quarter No. A/82, Zone-III., Imphal West, PO /PS :Lamphel.

That I have purchased the said homestead land from Shri Laikangbam Seitabrata Singh s/o Laikangbam Kuber Singh of Uripok, Achom Leikai, Naoremthong, Imphal West District in the early part of 2017 and have constructed my residential building G- Plus one pucca building and has been living in it since then. Apart from my residential building 2 (two) numbers of barrack type Quarters for my security escorts apartment has also been constructed with an attached granary and garage, toilet block etc.

On the 3rd of May 2023 a mob of valley based dwellers of Games village area ransacked and denounce our existence at this residential area at stake. As such, the area has been left to save our lives and could not confirm whether my residential house and properties were damaged/looted or not at the time of incident. However, I came to learn in the first week of January, 2024 my residential house was ransacked and looted all my household properties by unknown miscreants.

The approximate total value of the loss is estimated as under :

1. One Residential building (Pucca Building) G plus one (G+1)
Rs 2500000/ (Twenty five lakhs only)
 2. Two Barrack type Quarters used as security barrack and store room
@ Rs500000/ (Two lakhs fifty thousand only) used as security barrack.
 3. Fencing, Gate & Toilet Block @ Rs 400000/ one lakhs only
 4. Properties of olden artifacts, clothes , pipes ,electric posts, Portable rice mill, machines and equipments used for building houses and others @
Rs500000/(Five lakhs only)
 5. Plot value Rs 1200000/ (Twelve lakhs only)
- Total – Rs5100000/ (Fifty one lakhs only)

I fervently request your good office to kindly look into the matter for necessary legal procedure and protection from any form of forceful occupation of the said residential areas.
