We are the residents of the above address for the past 15 years and on 3<sup>rd</sup> May, 2023 I travelled to Shillong for personal work, on 4<sup>th</sup> May 2023, I came to know through my tenants who were staying in my house that the mob came to the house they run away from the house. All the items kept in the house Meitei miscreant vandalize and looted our properties. In the above said address had three storied building and my family members also were staying there and my tenants were there in the 4<sup>th</sup> floor. Their house was also looted just because of the fact that they stayed in a Kuki house. And I got this information from my tenants around 8:30 when I reach Nagaland.

Our Vehicle Mahindra Scorpio is burnt down by the mob and there is uncertainty about our educational certificates and documents of all our houses is safe. We have suffered a tremendous amount of financial loss, a full total amount include 2<sup>nd</sup> and 3<sup>rd</sup> floor of Rs 1.9 Crores including Jewels and Gold chains, household appliances.

I am a contractor, and due to this unrest and mayhem, I have lost all my files which are of bank documents, files of under construction document. And my wife is a high school Teacher who have also lost her source of income due to this mayhem.

Due to the displacement, me and my family have gone through terrible losses financially and are suffering from mental trauma and are left with no hope. I could not report to the concern Police Station due to prevailing Law and Order situation in the state.

Kindly, compensate me my lost, give us protection and take legal action against the perpetrator who have vandalize my house. Looking forward for your kind further necessary action in this regard.


