Sir.

It is to inform that on 18th August 2023 at about 1500 hrs, a group of 10-12miscreants, suspected to be from Meitei community, armed with Assault Rifles forcefully break open the lock of the Iron gate of "OMCRS Ebenezer's Children Home" located at Guigailong, Tarung, Opposite ICAR Farm (Meitei Langol)under the holding of Rev. S. LalpiVaiphei, S/o Paotinhen, Imphal.The armed miscreants illegally trespassed into a private property knowing fully that they are not a part or party to the ownership of the said property and carried out illegal searched of the premises with a criminal intention of killing/ kidnapping and rape underaged children, if found. The same miscreants, while leaving the private premises locked the gate with the lock and key brought by them with the criminal intention of illegally claiming/possessing the said property.

In furtherance to the illegal possession and claims of a private property, on 20th August 2023, at about 1300 hrs, 30-50 people comprising of womenfolk assisted by suspected ArambaiTenggol and Meitei Leepun men wearing black shirt and pants illegally entered the above said premise and looted the households and office properties estimated to be around 10,00,000 Rupees Ten Lakhs only. The said intruders have also pasted a print-out copy at the gate which reads "Universal Mothers Organization (UMO)" to falsify the ownership of the property and misrepresent the said institution. Some of the intruders illegally occupied the said premises/building which was once home to orphan children till the ethnic conflict. It is, therefore, prayed to take cognizance of the criminal offences committed in conspiracy with each other of the above armed Meitei miscreants, Meitei womenfolk, suspected ArambaiTenggol, Meitei Leepun, Universal Mothers Organization and any other person(s) involved and register a criminal case against the above persons under relevant sections of law of the land and book the culprits so that the rightful owner reclaimed his property from the hands of said criminals.
