Sir,

On the 4th of May, 2023 afternoon, about thousands of Youth suspected to be 'Arembal Tenngol', group from Meitei community, carrying guns and ammunition and other deadly weapons attacked the Khongsai Veng, Laipham Khunou, Imphal East, Manipur. Many of us were killed and injured. So, I and my family fled and hid in different places to save our life. On that same day, after we fled they had destroyed the locked door, vandalized/looted every pieces of our properties. Then they destroyed and burned down my residential house which is a semi-pucca wooden house having 2(two) storey with GI roofing located at Khongsai Veng (House No. 56), Laipham Khunou, having Patta No. 332/part(old), 1468/2230 (new), covered by C.S. Dag No. 1713/2514, measuring an area of 0.10000 acre in the name of my wife namely Nenneivah Khongsai and Patta No. 326 ang (old), 256/2056 (new), covered by C.S. Dag No. 486/2330, measuring an area of 0.6680 acre in my name.

Details of the vandalized/looted properties are given below:

7. TV 45 inches - 1, worth Rs. 53,000/-
8. Mattress - 4, worth Rs. 1,76,000/-
9. Sofa set - 1, worth Rs. 1,30,000/-
10. Washing machine - 2, worth Rs. 38,000/-
11. 1k liters Sintex - 1, 500 liters sintex - 1, worth Rs. 10,000/-
12. Generator (Honda) - 1, worth Rs. 80,000/-
13. Tullu - 1, worth Rs. 19,000/-
14. Solar plate - 3, worth Rs. 1,02,000/-
15. Inverter & Battery - 1, worth Rs. 15,000/-
16. Kitchen utensils, worth about Rs. 80,000/-
