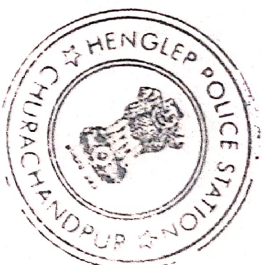

However on 14/09/2023 my just quarter neighbor who is a Meitei fellow informed me that all my house-holding furniture/properties in my said quarter were stolen away by unknown miscreants on the evening of 13/09/2023.

It is therefore, report you that harsh/necessary actions as deemed fit be taken up- soon as per law.
