That, One Mr. PH. John Singh using mobilephone no. 7630096151, had requested me to take refuge at my allotted Quarter located at the above mentioned address. It was mutually agreed between us that he would also look after the deserted household items / movable assest, as the same was sent to him under Mutual Agreement on Mobile SMS by me on the 11th of June,2023 at 5:08 PM.

That, hearing from a reliable sources, it has come to my knowledge that One Mr. PH. John Singh had looted, stolen and illegally shifted out the deserted household items / movable assests from the said quarter. Whilst, on confronting him on phone calls, Mr. PH. John Singh remained silent and later on, had blocked my mobile No., to which it proves that he is the perpetrator behind the criminal activities that was carried out at the staid quarter.

That, based on the facts of the reliable sources, the above mentioned criminal activities was carried out on the 20th of Nov., 2023 at around 3:30 PM, and the looted & stolen household items / movable assests from the said quarter is estimated to be about Rs.15,00,000/- (Rupees Fifteen Lakhs) Only.
