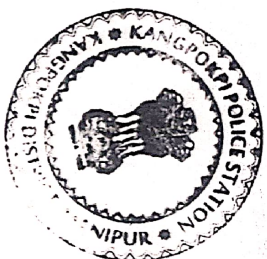

Subject: Request to lodge FIR.



I have the honour to report that, a large number of innumerable unidentified groups of people belonging to Meitei community with deadly weapons forcefully entered and stormed in all Kuki inhabited areas at Joseph Colony, Phaijjang, near Langol Lainingthou, Meitei Langol under Lamphel-PS, Imphal West District on 4th May, 2023. Due to this sudden outbreak of violence, we felt panic and suddenly left all our properties and home unattended and could not confirm that whether my house and properties were damaged/looted at that time.

However, in the last week of December, 2023, I came to learn and confirmed that, my residential house at Joseph Colony, Phaijjang, Langol was vandalised and looted all my household properties by unknown miscreants. The total approximate loss of my properties is estimated at 20,000,00/- (Twenty lakhs) only we.

It is therefore, requested to take up a legal necessary action as per the law of the land.
