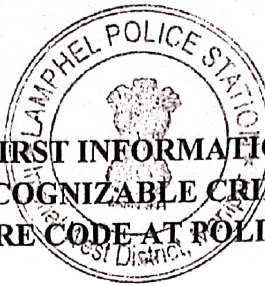

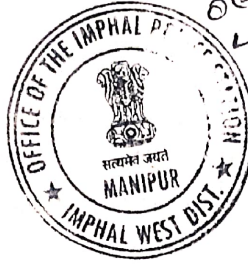

Sir,

I beg to state that on 4th May, 2023 at around 9:00 am our locality Khongsai Veng, under Lamphel Police Station and falling under the revenue of Imphal East was attacked by thousands of violent mob belonging to the Meitei community with and intent to murder the Kukis resulting in the area.

As a result of which many houses and properties were destroyed and burnt to the ground. My house No. 93, a two storey pucca building was also set on fire and was completely burnt by the mob. Below are the lists of movable and immovable properties damaged.

- a) Main building : 2 storeyed building. Estimated cost of the building exclusive of land is 2.5 crores.
- b) Wooden Houses: Garage, tree house, granary
- c) Estimated loss of property: (i) 4 nos. of sofa set (ii) 2 nos. of TV (iii) 2 sets of dining tables and chairs (iv) 4 nos. of Cooking gas cylinders (v) 5 nos. of beds (vi) Kitchen-wares (vii) 6 nos. of traditional gongs (viii) Inbuilt almirahs etc. Estimated cost of the above is Rs. 15 lakhs.

It is therefore, requested to kindly take up necessary legal action as per the law of the land.
