Lamphel, Distirct-Imphal West.

Due to such unprecedented attacked of ethnic cleansing of Kukis at Imphal, we being in state of vulnerability, fearing to lose our lives. I along with my family fled from our residential house and took refuge at the 143<sup>th</sup> Battalion, CRPF Camp at Lamphel near Exchange Office.

Upon Enquiry, I came to learn that my residential house was ransacked, vandalized and looted by the miscreants on 2<sup>nd</sup> August, 2023 around 9 AM.

I therefore, pray to your kind self to intervene and register a complaint (Zero-FIR) of cognizable offence carried out against me and my family for the ends of Justice.
