I. have the honour to state that, on 4-05-2023 at around 3:20 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-2000 persons carrying Sophisticated weapon forcefully attacked and entered our locality at Khongsai veng, Laipham Khunou, Imphal East Dist. Manipur about 42 Km South from Saikul –PS in which the unknown violent mob vandalised my house and looted all the moveable and valuable household proprerties and burnt down all the remaining items to the ground.

That, recently through reliable source it is learnt that, some unknown miscreants dismantle the remaining structure of my house and removed all the bricks portion and looted.

Since I was outside Manipur for some personal and family matter I could not report to the concerned authority in time.

The list of properties destroyed or loss are mentioned in the Annexure (enclosed).

The Approximate value of lost properties is calculated at about Rs. 2,85,00,000/- (two crore eighty five lakhs) only.
