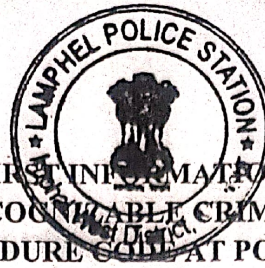

Subject: Report on crimes of looting, vandalism and discrimination of Scheduled Tribes.

With references to the above cited subject, I have the honour to report to you as follows;

I am a scheduled tribe belonging to the Zou Tribe, which is a recognized tribe under the Constitution of India and a permanent resident of T Phailen Village, Sajik Tampak, P.O. & P.S.- Chakpikarong & district- Chandel, Manipur.

That, on the 17th of Aug., 2023 at around 12:30 PM, with the help of a good friend belonging to different Tribe/Community, it came to my knowledge that a group of Meitei / Meitei miscreants suspected to be members of Arambai Tenggol, Meitei Leepun and the iocais in and around the area, broke open the Gate of the premises and in the process they have looted and vandalized the construction tools / machinery along with the temporary store room and others, located at Langol (Phaipijiang), bearing Patta No. 141/487/4333, covered by CS Dag No. 1064/2839, P.O. & P.S.- Lamphelpat and district- Imphal West. Manipur.

That, it may also be report that the said criminal activities have cause grave mental agony and incurred huge lose which is estimated to be about Rs. 35,50,000/- (Rupees Thirty Five Lakhs Fifty Thousand) Only.

That, the reason behind my late FIR is that I was at different remote areas for months

Therefore, I humbly pray you to kindly register a ZERO FIR, and booked the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
