Sub: Report.

Sir,

I have the honour to state that today i.e., 05/06/2024 at about 5:00 pm a team led by ASI. N. Wipoubou Special Operation team Mao PS, while conducting random frisking and checking at Mao Police check post along NH-2. During which, the teams stopped one tourist bus bearing no. MN-01BA-0222, (Blue and white in colour) proceeding towards Nagaland and on checking, one of the passenger, who was found in suspicious manner, who identified himself as Singamayun Sheikh Akram (28 yrs) s/o Moulana Ahmed of Phoudel, Yairipok, Thoubal District Manipur. He was tactfully questioned and finally admitted to have possess items concealed inside his black frontech woofers. On confirming the presence of suspected contraband drugs, the executive Magistrate Shri.Ch. Neli SDC Senapati Sub-Division was informed about the matter and arrived at the spot for witnessing necessary procedures. In the presence of the said executive Magistrate and two civil independent witnesses, the passenger namely Singamayun Sheikh Akram (28 yrs) s/o Moulana Ahmed of Phoudel, Yairipok, Thoubal District Manipur has taken out 8 (eight) soap cases of concealed drugs (i.e suspected to be brown sugar) which were neatly stacked inside the black frontech woofers. On production by the said passenger, the recovered 8 (eight) soap cases were weighed by using weighing machine in presence of the Executive Magistrate and detained person and it was found to be 94.00 gms (including the weight of eight transparent plastic packet, excluding the weight of 8 (eight) Soap cases)

The recovered 8 (eight) soap cases containing 94.00 gms (including the weight of eight transparent plastic packet, (excluding the weight of 8 (eight) Soap case cover) suspected to be containing brown sugar and the undernoted items were seized in presence of Executive Magistrate, two civil independent witnesses and the detained person at 5:39 pm by preparing a formal seizure memo and also obtained their signatures. The detained person was formally arrested at 5:50 pm by observing formalities.

**Particulars of the seized items: -**

- 1) 1 (one) woofers (frontech) black color
- 2) 8 ( eight) nos. of soap cases containing suspected brown sugar 94.00 gms (including the weight of eight transparent plastic packet, excluding the weight of 8 (eight) Soap case cover)
- 3) 1(one) realme mobile phone (narzo) IMEI No. 869460057795532, IMEI no. 869460057795524 along with sim card. Bearing regd. No. 8119991573
- 4) 1 (one) PAN CARD no. CHJPA1769C
- 5) One brown wallet containing RS-1190/- (One thousand one hundred ninety) containing two-five hundred rupee note, one- one hundred rupee note, four- twenty rupees note, one- ten rupee note.

Therefore, the one detained individual and seized items are handed over to you for taking further necessary legal action please.
