Subject: Report on assault of one police personnel by Peimiyo (32 Yrs) S/o (L) AS
Shangreihao of Dungrei, Hungpung, Ukhrul district, Manipur

Sir,

Today i.e, 21/05/2024 at 11:16 a.m, received a reliable information that one individual identified as Peimiyo A.S (32 Yrs) S/o (L) A.S Shangreihao of Dungrei, Hungpung Village, Ukhrul district, Manipur resorted to creating public nuisance at District Hospital under the influence of alcohol today i.e, 21/05/2025 at around 11:00 a.m. Taking note of the situation, the police personnel deployed at District Hospital reacted swiftly and tried to control the situation. While the police tried to bring the above mentioned individual under control, instead of complying to police, he turned towards the police and punched one police personnel identified as C/No. 1806250 Horngam YR (28 Yrs) S/o Ngachonmi YR of Dungrei village, Ukhrul district on the face and hurt him. The accused then punched more blows to the victim, but, the victim averted the punches that followed. The accused was overpowered then and there by the police personnel. On received of the information, self being the Day Duty Officer of Ukhrul Police Station rushed to the spot i.e, District Hospital, Ukhrul and took the accused person into custody after proper identification. The family members were also immediately informed and briefed them well the reason for taking him into custody. The accused himself had also acknowledged and admitted to the charges that he had physically assaulted the victim.


Submitted this report for taking further legal action against the accused person.
