

Subject: - Request to lodge an FIR regarding theft incident.

Dear Sir,

With reference to the subject cited above, I would like to lay down few words that today i.e. on 21/05/2024 at about 9:30 am while I along with other staff members reached our office located at Jiribam Multi Utility Complex 2nd floor, we observed that two numbers of locks were found broken which were put at the shutter of eastern side main door and also it is observed that the CCTV camera facing the said door is also found covered with polythene bag. Further, on opening the main door it come to our notice that the small safe was found damaged as well as the two layers of strong room door i.e. one iron door and another collapsible door was also found opened by breaking two numbers of locks on each door. On further verification it was found that a sum of Rs 30500/- (coins) was lost which was kept inside the strong room in a steel trunk. Later we come to know that the CCTV camera which is installed in front of the strong room is also found broken. It is highly suspected that the theft incident was occurred in the intervening night of 20/05/2024 and 21/05/2024 by some unknown persons.

It is therefore, you are requested to kindly do the needful lodging an FIR in this matter.
