I have the honour to state the following few lines before you for your kind perusal and favourable action.

- 1. That, I married Smt. Rosilin Chetry on 1<sup>st</sup> March 2006, by performing religious rituals according to our Nepali custom. Out of our marriage, she gave birth to 4 children namely (i) B. Nigetha 9 yrs (daughter) (ii) B. Devitha 7 yrs (daughter) (iii) B. Nekhil 7 yrs (son) and (iv) B. Sunita 5 yrs (daughter). They are all studying in Class-III, II, II kg and Nursery.
- 2. That, about 1 ½ years back I along with my wife were residing at diary farming at Nunpani (Nepali Village) Kangpokpi District. I am also doing business of sale and purchase of cows. On 4<sup>th</sup> March 2024, while I was at Sekmaijing Village, Thoubal District, my wife informed me that, she left my farm as she eloped with Mr. Filimon (25 yrs) S/o M. Dene of 10 Mail, Garu Basti Widungchuk Village, District, Assam P.O. & P.S. Dilai.
- 3. That, on the next day, I returned to my temporary home. I found that, she took away a sum of Rs. 6,50,000/- (Rupees six lakh and fifty thousand) and gold ornaments valued about Rs. 2,50,000/- (two lakh and fifty thousand). She also took away my last daughter namely B. Sunita (5 years) in her custody. Therefore I search for her for some few days.
- 4. That, having no alternative on 10.03.2024 I went to Senapati Police Station for a report but some police personnel advised me to report to the Kangpokpi Police Station. Again on 12.03.2024, I went to the Kangpokpi Police Station to lodge a report, but some police officials after hearing my story, told me that, the police did not register such type of case as it is a family matter.

On the facts and circumstances stated above, I request you kindly to rescue my minor daughter namely B. Sunita (5 yrs) and hand over to me and to take legal necessary action against Mr. Filimon (25) years S/o M. Dene of 10 Mail Garee Basti Widungchuk Village P.O. & P.S. Dilai, Assam and my wife and published them according to law.

For the act of your kindness, I shall ever remain thankful to you.
