**Subject: Report.**

Sir,

I am writing to report the recovery and subsequent submission of a cache of weapons and ammunitions as part of an operation conducted by a joint team of C-Coy 22 Assam Rifles, E-Coy 16 Assam Rifles and District Police Kangpokpi, in accordance with the specific Reliable information from own source.

On the aforementioned date, based on specific input was shared by intelligent agency regarding the movement of unknown armed miscreants at the jungle in the general area of Maohing, I.T Road approximately 3 kms North West of Maohing Kuki Village. In response to this information, a joint team comprising 22<sup>nd</sup> Assam Rifles C-Coy (COB Kangpokpi), 16<sup>th</sup> Assam Rifle E-Coy (COB Hengbung) and Kangpokpi Police launched a search operation today i.e. 18/05/2024 at 0930 hrs. During the search operation conducted by the combined teams, the unknown armed miscreants were already fled away from the scene however, the following arms were seized from the spot at 1145 hrs. The combined search operation was terminated at 1155 hrs.

**Particulars of the recovered items :**

1. 01x SMG 9mm Carbine-A (Regn. No. N915227568) with empty magazine.
2. 01x 9mm Pistol (local made) with empty magazine.
3. 01 x .22 Pistol (Local Made) with empty magazine.
4. 04 x .22 mm (KF) live rounds.
5. 03 x 9mm (2Z) live rounds.

The recovered arms ammunitions are being handed over to you for further necessary action.
