## 13. First Information contents:

The brief fact of the case is that some unknown miscreants have looted some electrical items from inside the rooms of underconstructed pre-fabricated house comprising of 140 (One forty) rooms for displaced persons at Ngahmun village Relief Camp in the midnight of 16th July 2024. The incident came to be known by the complainant in the early morning of 17th July 2024 when he checked all the connected electrical wire in the room. The following electrical items were found looted:

I have the honour to report that I have constructed pre-fabricated house comprising of 140 (One forty) rooms for displaced persons at Ngahmun village Relief Camp. The construction work had been started since 18<sup>th</sup> February, 2024 and is still continued and the work is on progress. It is working under the contract of EPACK Polymers Pvt. Ltd. That, in the early morning of 17<sup>th</sup> July, 2024 when I had checked all the rooms for testing the connected electrical wires, I came to know that some electrical appliances were found missing. It must be looted by unknown miscreants during the midnight of 16<sup>th</sup> July, 2024. The following electrical items were found looted:
