13. First Information contents:

The brief fact of the case is that some unknown miscreants have looted some electrical items from inside the rooms of underconstructed pre-fabricated house comprising of 140 (One forty) rooms for displaced persons at Ngahmun village Relief Camp.in the midnight of 16<sup>th</sup> July 2024. The incident came to be known by the complainant in the early morning of 17<sup>th</sup> July 2024 when he checked all the connected electrical wire in the room. The following electrical items were found looted:

1. 44 (Forty four) Nos. of Volt Care (Fan) - 44 X 1300 = Rs. 57,200/-
2. 23 (Twenty three) Coils of Electrical wires - 23 X 800 = Rs. 18,400/-
3. Bulb (2 Boxes) 50 Pieces - 50 X 90 = Rs. 4500/-
4. 32 (Thirty two) pieces of MCB Box - 32 X 70 = Rs. 2240/-

The approximate value of the lost electrical items are estimated as Rs. 82,340 /- (Rupees Eighty two thousand three hundred and forty only). Hence a regular has been registered under FIR No. 28(7)2024 KPI-PS u/s 305/331(2) BNS .

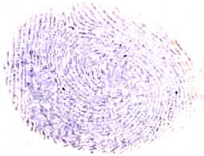



Sir,

I have the honour to report that I have constructed pre-fabricated house comprising of 140 (One forty) rooms for displaced persons at Ngahmun village Relief Camp. The construction work had been started since 18<sup>th</sup> February, 2024 and is still continued and the work is on progress. It is working under the contract of EPACK Polymers Pvt. Ltd. That, in the early morning of 17<sup>th</sup> July, 2024 when I had checked all the rooms for testing the connected electrical wires, I came to know that some electrical appliances were found missing. It must be looted by unknown miscreants during the midnight of 16<sup>th</sup> July, 2024. The following electrical items were found looted:
