Bashiruddin of Yairipok Laimanai and that he was abducted at gun point by some unknown persons and taken away in a Baleno car blue in colour. It is also learnt his (Aktar's) wife received a call from the Aktar's mobile number 7005064020 at around 11:30 pm yesterday, the 30th May 2024 asking huge amount for his release. The caller identified himself as member of KCP(NRFM).

So, a suo motto case is taken up under FIR No. 8 (05) 2024 APS u/s 400/364A/34 IPC and 25(1-C) A. Act for investigation into the matter.
