Sir,

With due respect, I have the honour to report that today i.e. 17/04/2024, at about 5:30 a.m. by a combined team 16 AR & 28 AR and teams of CDO/IE Unit assisted by ASI. Sujoy Deb of CDO/IE commanded by Inpst. Kh. Henery Singh OC-CDO/IE under the guidance of Shri. Kh. Herojit Singh, MPS, Addl. SP(Ops)IE and under the overall supervision of Shri. K. Meghachandra Singh, MPS, SP/IE conducted a cordon and search operation in the general area of Sanjenlok Village and its surrounding hill range of Imphal East District.

In that, around 30/40 houses were checked and verified. During the search operation the under noted arms, ammunition, explosives etc. were found lying abandoned/concealed at the hill top of Sanjenlok, Imphal East District by some unknown miscreant with an intention for committing pre-judicial activities.

1. 1 (one) 12" Single Barrel rifle (Country made),
2. 1 (one) no. Carbine (Country made)
3. 1 (one) no. of carbine magazine (Country made),
4. 1 (one) no. of .32 Pistol bearing R/No. 0710 7ROU, marked as "Made in USA A. Pistol", without Magazine.
5. 2 (two) nos. of Hand Grenade (Country made),
6. 1 (one) no. of Smoke grenade,
7. 2 (two) nos. of 12 mm Shot Gun bullets (JMK3T)
8. 1 (one) no. of 38 mm rubber bullets,
9. 1 (one) no. of Stun Shell grenade and
10. 1 (one) jacket.

Accordingly, the above recovered arms, ammunition, explosives etc. were seized u/s 102 CrPC at 6:40 a.m. from the hill top of Sanjenlok, Imphal East District by observing due formalities.

Therefore, the seized items are being handed over to you for taking up further necessary legal procedures.
