Sir,

With due regard and humble request that on 26th April, 2024 at about 4:30 pm received an information that on the same day at about 4:20 pm my younger brother(village volunteer) namely Laishram Prem Meitei @ Bungomacha aged about 33 years S/o. L. Norendro Meitei of Sinam Mamang Leikai, Imphal East District, Manipur along with some local volunteer while guarding the peripheries villages of Sinam village at Meikham hill of Sinam village, some unknown armed Kuki militants ambushed against them by using sophisticated weapons along with Bomb. In which, my younger brother was slippery into a ravine while he was helter- skelter for escaping from ambushed.

However, due to contentious firing and became dark night he could not be rescue in time. On 27/4/2024 at about 6:30 am his dead body was recovered from a ravine of Meikham hill located at Sinam village.

I therefore request to kindly taken up further legal action against the unknown armed Kuki militants.
