At around 1600 hrs, the mobile check post observed movement of a suspected SUV-700 vehicle bearing vehicle No MN01AG5061. The suspected vehicles was made to stop at the MCP location for checking. On checking of the vehicle, two men namely Mr Thingujam Sanathai Meitei, 21 years old and Mr Meinam James Singh, 32 years old were found with a 12 bore double barrel gun alongwith 19 live rounds. While interrogation it was found that the gun was illegally carrying by them as they were not in possession of valid license. As per intelligence report both the members belong to the KYKL outfit. While interrogation was in progress, the locals and Meirapibis started gathering at MCP location. So both the individual resisted to move to Thoubal Dam Police station. Hence both the individual left at the MCP location and the confiscated weapon and ammunition were carried to own Company Operating Base.

Hence it is requested to lodge an FIR against them as both are from KYKL outfit and for illegal possession of Arms, ammunition and vehicle.
