I the under signed have the honour to state that, on 12/06/2024 at 6:10 pm while I was residing at Sandong Makha Leikai Community Hall Relief Camp a reliable information was received that my daughter namely Ahongsangbam ningol Wayenbam ongbi Bidyaluxmi Leima aged about 19 years was found hanging at her husband (Wayenbam Suraj Meitei) house located at Uyumpok Terapur, Imphal East District, Manipur at around 5:30 pm of the same day and her family members put down her hanging body and evacuated to CHC Sagolmang. Conducted a medical treatment to save her live, but unfortunately she was expired on the same day at about 6:25 pm.


In the earlier, my late daughter said that she (Bidyaluxmi Leima) was assaulted and cruelly abuse by her husband. So, the dead of my daughter is highly in suspicious.


