Sir,

- 1. Indian Army columns are deployed in general area Itham, Tumukhong, Moirangpurel, Monghlam Base, Nongdam Tankhul in aid to civil authorities. Based on specific input, on 18 May 2024, a vehicle with Registration number AS02CC-7324 (TATA YODHA)(photographs of the vehicle attached) was intercepted. 07 indls (allegedly belonging to banned outfit KCP and KYKL), who were intending to launch attack from Itham and to initiate a firefight in General Area Kamu were found in possession of illegal arms and ammunition inside the vehicle. They were apprehended by Indian Army column along with weapons and war like stores at around 12:30 hrs on 18 May 2024.
- The 07 individuals (allegedly belonging to banned outfit KCP and KYKL), were found in possession of undermentioned war like stores(photographs attached) -
  - a. 1 (one) Insas Rifle 5.56 mm body No. 18531126 along with one magazine.
  - b. 1(one) Insas LMG magazine.
  - a. 38 (thirty eight) no's of 5.56 ammunition (Insas).
  - d. 1 (one) 303 Rifle body No. 87440 with magazine.
  - e. 9(nine) 7.62mm rounds.
  - f. 1 (one) Single Barrel (SBBL-12 bore) Body No. VS31225.
  - g. ! (one) Single Barrel (SBBL-12 bore) Body No. VS31227.
  - h. 12(twelve) Bore live round.
  - i. I (one) Binocular namely Xpedition xpert.
  - 1(one) Khukari with cover.
  - k. 1 (one) 12 bore ammunition belt.
- 3. In the meanwhile, before the columns of Maphou Dam police could reach the location, the local villagers and unlawful assembly of rioting Meira Paibis congregated to deliberately block the route so as to facilitate the escape of vehicle containing the indls. During this commotion created by the violent unlawful assembly,7 individuals managed to escape in the garb of violent and riotous mob of Meira Paibis and villagers, however, Indian Army columns successfully managed to transfer the seized weapons from the site of the incident to Island COB.
- When the column reached Island COB, the unlawful riotous mob of around 300 Meira Paibis under Mrs Shayyarit I eader of Itham village of Meira Paibis ) blocked the entrance to the COB and were protesting to hand over the seized weapons. Several attempts were made by the local police under SI Maphou Police Station to calm the violent mob of women, however, the riotous mob continued their violent protest.(photographs of the violent mob attached).
- 5. Meanwhile, an individual named Mr. Raimanow (alleged coordinator of mob of Meira Paibis) was found with local radio set making videos and also instigating and inciting mob of Meira Paibis from Tumukhong and Moirengpurel to further block the entrance to COB. The details of the individuals were handed over to the police.
- 6. In view of the above, FIR against unknown/unidentified rioting Meria Paibis(photographs attached) and other rioters in general area Moirangpurel, and Itham may be lodged for the following offences:
  - (a) Obstructing public servants from discharge of their official duty in suppressing and dispersing unlawful assembly contrary to \$ 353, 503, 504 and 506 of IPC
  - (b) Assisting/aiding escape of the armed miscreants from the lawful custody of Indian Army while performing bonafide military duty in aid to civil authorities contrary to S 201, 224, 225 of IPC



- (c) Criminal intimidation, assault and criminal force against public servants discharging public duty in aid to civil authorities contrary to S 34, 120, 332, 350 of IPC
- (d) Obstructing public servants in apprehending the armed miscreants and unlawfully resisting their arrest contrary to S 201, 224, 225 of IPC
- 7. In view of the above, FIR against unknown/unidentified 07 indls(photographs attached) (allegedly belonging to banned outfit KCP and KYKL) may be lodged for the following offences:
  - (a) Possession of illegal arms and ammunitions contrary to S 25(1C) and S 27 of Arms Act, 1959
  - (b) Criminal intimidation, assault and criminal force against public servants discharging public duty in aid to civil authorities contrary to S 34, 120, 332, 350 of IPC
- 8. In view of the above, FIR against Mr. Raimanow (alleged coordinator of mob of Meira Paibis) may be lodged for the following offences:
  - (a) Criminal intimidation, assault and criminal force against public servants discharging public duty in aid to civil authorities contrary to S 34, 120, 332, 350 of IPC
  - (b) Instigating and abetting unlawful assembly of Meira Paibis contrary to S 107, 34, 120 of IPC.
- 9. In view of the above, FIR against Mrs Shayyari( Leader of Itham village of Meira Paibis ) may be lodged for the following offences:
  - (a) Obstructing public servants from discharge of their official duty in suppressing and dispersing unlawful assembly contrary to S 353, 503, 504 and 506 of IPC
  - (b) Criminal intimidation, assault and criminal force against public servants discharging public duty in aid to civil authorities contrary to S 34, 120, 332, 350 of IPC
