I have the honour to report that, on 22/06/2024 at about 6:10 am a reliable input was received regarding weapons cache. Accordingly, a combined team comprising of one CDO team of Imphal East led by myself along with one team of Sagolmang PS, a column of each 16, 22 & 28 Assam Rifle, under the supervision of Shri K. Meghachandra Singh, Superintendent of Police, Imphal East launched an Cordon and Search Operation (CASO) at 9:30 am at general area of Ishingthembi to hill area near Kongba Maru. During the search operation, the undemoted arms, ammunition, explosive etc. are found suspecting to be concealed by miscreants at hill area near Kongba Maru.

2. 1(one) no. of country made 9mm Pistol marked No. 6137 with one Magazine.
3. 1(one) no. of country made 7.65 mm Pistol marked as USA with one Magazine.
4. 1(one) no. of broken Bompi.
5. 3(three) nos. of HE Hand Grenade without detonators.
6. 10 (ten) nos. of 7.65 mm live rounds.
7. 1(one) no. of Walky-Talky set with battery mark as BAOFENG.

Accordingly, the above items are seized from hill area near Kongba Maru at 10:40 am by observing formalities. The operation was concluded at 11:45 am of the same day.


The seized articles along with the seizure memo are handed over to your good office for taking further legal proceeding.
