I have the honour to report that, today i.e. 29/06/2024 at about 3:00 am a reliable input was received regarding weapons cache. Accordingly, a combined team comprising of CDO teams of Imphal East led by Shri Th. Sudhir Singh, MPS, DySP (CDO Imphal East) along with a team of Sagolmang Police Station, a column of 16th - Assam Rifle and a column of 28th Assam Rifle under the over all supervision of Shri Kh. Herojit, MPS, Addl. SP (OPS) Imphal East launched an Cordon and Search Operation (CASO) at Kongba Maru Hill ranges at 4:30 am. During the search operation, the under noted arms, ammunition, explosive etc. are found suspecting to be concealed by miscreants at the mid hill area of Kongba Maru Hill Range .




The seized articles along with the seizure memo are handed over to your good office for taking further legal proceeding.
