Sir,

I have the honour to state few lines about my problems in need of your kind action.

That, I am an inhabitant of Mongneljang village under Saikul Sub-Division, Kangpokpi District, PO & PS – Due to the on-going ethnic violence, I have left my village on 3<sup>rd</sup> May 2023. There was no issue of burning houses or the like till today. But, the saddest part us that, I came to know that, although our house was not burnt, all our household properties were damaged and looted by unknown miscreants thereby leaving the house empty through one of my friends on 27<sup>th</sup> August 2023 at 6:30 Am. Being settled in the Relief Centre, and due to repeated ailments and sickness of my family members, I was totally ignorant to report the case to the Police Station which resulted in the late report to Police Station.

As such, there is no single hope for me to retrieve the lost properties in this IDP status. The total lost assets is calculated to be around Rs. 6,53,000/- Rupees ( Six Lakhs fifty-three thousand) only.

Therefore, I humbly request you kindly to register FIR over the above mentioned issue.

For which act of your kindness I will remain thankful to you.
