Sir,

With profound veneration I, the undersigned, lay down a few lines for your kind consideration and needful actions thereof.

That, I was born and brought up at Yairipok Angtha Mayai Leikai, Imphal East under Andro Police Station presently staying at Khuyathong Polem Leikai, Imphal West. I am law abiding citizen of India.

That I have been receiving threatening calls and messages from the unknown mobile numbers since the mayhem came about in the state about in the state as a result of which I have an apprehension of dire consequences. In this regard I have already filed a representation to the Superintendent of Police Imphal East to take up needful initiative for safety and security of my life.

In the meantime on Sunday, the 21<sup>st</sup> April 2024 at around 11:30 am when I was returning from Antha along with my elder sister after participating a ritual ceremony of a deceased uncle, a Mercedes sedan car, red in colour over took an blocked my TUV car at Ngariyan near Mini Market along Imphal -Yairipok Road.

All of a sudden, four miscreant armed with sophisticated weapons surrounded my car and told me to come out of the car in high tune. One of the culprits told his fellow kidnapers to pick up the blue colour T-Shirt was none but me. They heartily grasped my wrist and pulled me inside the car. At that time my sister was trying hard to stop them but she could not. They did not allow me to look outside the car so I had no idea where I was being taken away.

Later on, it came to light that I was somewhere in Ingourok village area from an ID card of a school girl from the house where I was kept concealed. While I was in their custody, they interrogated me lots of unreasonable question with a mala fide intention to extort money from me even they pointed the muzzle toward me nevertheless I had nothing to answer except to face the consequences of their rude action.

Afterward they asked me to give me them a contact number of my family however I did not as I don't remember it so I told them to get it from the instagram account of my wife. They got the contact number of my father in law and had a conversation with him. I have two different mobile numbers 6909528271 and 6909528274 which my kidnappers used to contact my family on that day.

At around 10:50 pm somehow I managed to escaped from the hide out, took a auto rickshaw somewhere from Nongpok Sekmai area and got home safe and sound at around 12:40 am.

I could not file my complaint report to the police station timely as I had to discuss to some legal experts and my elders on that matter for an effective and fruitful outcomes.

It is therefore, drawing the lenient sympathetic attention of the respective officer in charge, Andro Police Station to take up needful legal Action against the culprits and to ensure the safety and security of my life and family as well in near future.

I shall ever be grateful for your prompt actions.
