I am to state that today i.e. 09/06/2024 at about 1:10 pm a specific input received from 5/9 Gorkha Rifle regarding presence of one suspected person unlawful activities at the area of Andro. On receiving the information a teams of Special CDO unit led by Jem. N. Michael Singh of Special Commando Unit, Khabeisoi assist by HC. T. Anou Meitei rushed to the said area and conducted cordon and search operation at Andro near power house of Imphal East District. Manipur. On questioning, he revealed that he was a member of valley base underground banned organization KYKL (Fraction) Sorepa and joined in the year June, 2021 through one Mr. Iboshana Singh age about 55 yrs of Lamsang Taothong got basis training at Thanan Myanmar center and his Army No. is 509. He is holding the post of sergeant Major in the said organization. He admitted that he is working under the command of Mr.Lala @Nanao Chairman of this group and demanded monetary assistance for the general public and Businessmen at Imphal East District and collected huge amount of money from the General Public and Businessmen. Govt. office etc.

So, from the above facts and circumstances he was arrested at the spot at 3:40 pm of 09/06/2024 and hand over to Andro Police Station for further necessary legal action against him.
